In India, homosexuality was considered a crime before 2018, but the Supreme Court on 6 September 2018, while announcing the landmark verdict, abolished Article 377 of the Indian Penal Code which considered homosexuality a crime. Relationships cannot be called crimes. This was considered their right. The bench unanimously held that a part of Article 377 violates the rights of Section 14 and 21.

PAKISTAN

Homosexual relationships are a crime in Pakistan. In Pakistan, there is a provision of life imprisonment for a sexual relationship. But in 2018 a law was passed to recognize the third gender in Pakistan. Those demanding rights of gay rights in Pakistan say that it is not safe to say openly gay there.

NEPAL

Nepal implemented the new constitution in September 2015. It ensured the rights of minority communities. Earlier in 2007, homosexuality was removed from the category of crime, but in 2015, homosexuals were not allowed to marry here.

BANGLADESH

Homosexuality is considered a crime in Bangladesh. There is a provision of life imprisonment for 10 years punishment for making a gay relationship. In 2016, a man demanding the rights of two homosexuals was assassinated.

SRI LANKA

Homosexuality is also considered a crime in Sri Lanka. There is a provision for imprisonment for life from 10 years. There in 2017, the cabinet rejected the right to exclude homosexuality as a crime.

AFGHANISTAN

Homosexuality is considered a stigma in Afghanistan. One can be sent to jail for having a gay relationship there.

MYANMAR

Homosexuality is considered a crime in Myanmar. There is a provision of fine and imprisonment up to 10 years.

CHINA

Homosexuality is not considered a crime in China. In 1997, homosexuality was removed from the category of crime. Homosexuality is considered a mental illness in China. This is not a sex allowed to marry, but homosexuals are allowed to marry in Taiwan.

USA

Homosexuality is not considered a crime in America. Here you can freely say that you are gay. Harvey Bernard Milk (22 May 1930 - 27 November 1978) became the first American politician to openly admit that he was gay. He fought hard for this issue and won the election of San Francisco Board of Supervisors by making it his election campaign. Sadly, he was also murdered for the same reason. Homosexuals are not allowed in the army. Homosexuals can get married among themselves.
