In India, the present generation lives in the new information age as a result of rapid development of Internet and its easy accessibility. For example, Sinha (2010) reported that



around four percent users in India browse Internet only through mobiles, and that Internet usage in general has gone up from 9.3 hours/week to 15.7 hours/week. Similarly, in an interview to NDTV on March 21, 2013, the Executive Chairman of Google, Eric Schmidt stated that there were an estimated 600 million mobile users and 130 million Internet users in India including 20 million broadband users (NDTV, 2013a). According to a July 2012 report in the Times of India, a leading newspaper, Face book had 50 million users in India, and most of them were accessing Internet through mobile phones (NDTV, 2013b). In its 2013 report, Face book reported that as of December 2012, it had 71 million users in India (NDTV, 2013b).

It has been seen that the use of Internet is increasing at a phenomenal rate in our country, with approximately 120 million Internet users as of 2011 (Internet World Stats, 2011) and 130 million as estimated by the Executive Chairman of Google Eric Schmidt for 2013. In India too, the number of Internet users has grown fivefold from 2005 to 2011
