

- Nursing students had lacking in clinical/ real life exposure during this pandemic period.

iii) EXAMINATION

- While coming to examination both teaching faculties and nursing students faced various technical issues in conducting and writing theory examination.
- In theory examination few students not able to continue to next session and not
 able to answer all questions due to hanging of their electronic devices and
 automatically the correct answer turned to wrong option during the click of
 submission button due to technical error & evaluation done automatically by the
 system.
- As there is no clinical real life exposure and lab exposure, practical examination & evaluation held into trouble. Evaluators had faced difficulties in evaluating student's practical skills and their practical knowledge.

SOLUTIONS IN NURSING EDUCATION DURING COVID-19 PANDEMIC:

i) THEORY

- Campus class room lecture were replaced by virtual theory lectures and were implemented through online teaching platform like zoom, google meet, black board collaborate ultra, webex meet, microsoft online teams, GoToWebinar, group chats, screen sharing, recording.
- Teaching faculties and nursing students used online learning platform through various features like announcement, assignment submission, discussion, grade book, files upload, syllabus, modules, chat, communication, speed grader, presentations, symposium, workshop, quizzes, exams, conferences.

ii) PRACTICAL

- To overcome the challenges in gaining clinical practical skills nursing faculties choose virtual simulation like ATI real life, i-human kalpan, etc. Here nursing students get some what knowledge in clinical practice and it will be useful for them while entering into the real life situation.
- Given various group and individual clinical scenario were given to the nursing students to impart clinical knowledge.
- In accompanied with hospital authorities nursing students were encouraged to participate in tele-nursing, tele-health programmes to give health education, collecting history from the clients from remote places.

- Virtual clinical case presentation and viva were conducted through blackboard ultra, zoom
- ATI TEAS (Assessment Technologies Institute-Test of Essential Academic Skills) is designed specifically to assess a student's preparedness entering the health science fields. The Test of Essential Academic Skills (TEAS Test) is a standardized, multiple choice exam for students applying for nursing school in the USA. It is often used to determine the ability of potential students to adjust to a nursing program. The test is created and administered by Assessment Technologies Institute. On August 31, 2016, the TEAS V test was retired in favor of the newest version called ATI TEAS. While the difficulty is essentially the same, all components were updated to latest standards of the profession. The exam is 209 minutes and consists of 170 questions, drawn from a TEAS Test Bank consisting of thousands of questions that are given on several versions of the exam. The topics covered are reading, mathematics, science, and English language and usage.
- Proctored exams are those done under the supervision of a proctor, or supervisor, in a controlled setting. Testing in a proctored setting is done in a fullscreen mode. With this in mind, students are not to leave the full-screen browser until their test is complete. During testing, be sure that they are not clicking outside of the browser or trying to close the window that the test is in.

CONCLUSION

COVID-19 brings lots of changes in an educational system of many countries around the world. Educational institutions were closed to reduce the spread of this pandemic. The quality of the educational preparation provided to nursing students should be in an innovative manner and curriculum should be planned in an effective manner to impart the clinical and theoretical knowledge during COVID-19.
